## **Silencer QuickLay** *Vinyl Spray Adhesive*

Foam Products Corp. warrants that Silencer QuickLay spray adhesive will maintain its bond for the life of the flooring installed. This warranty applies to the installation of all luxury vinyl plank, vinyl tiles, and carpet tiles when used in strict accordance with both the flooring manufacturers and the Silencer QuickLay written installation instructions including but not limited to; acceptable subfloor types: concrete, gypcrete, plywood, standard OSB with normal flooring level, moisture/temperature and expansion requirements.

**Do not install vinyl flooring directly over OSB with the spray adhesive, must install with the Silencer LVT underlayment.**

**Do not install directly over Advantech® or similar moisture resistant brands of OSB. These chemically treated brands resist the bonding to the spray adhesive. Use a primer first.**

### **Exclusions:**

The warranty does not cover damages to the installed flooring caused by, *but not limited to*:

- Outdoor applications.
- Abuse, misuse or defects with the vinyl and carpet tile flooring.
- Standing water, fire, floods or natural disasters.
- Damages resulting from installation errors, or from improper maintenance.
- Failure to follow the Silencer QuickLay printed installation instructions and tolerances.
- Failure to follow the flooring manufacturer's printed installation instructions and tolerances.
- Hydrostatic (water) pressure, vapor emissions as well as excessive uncontrolled moisture and/or temperature
- Water damage due to any leaks, including, but not limited to leaks in walls, windows or floors.
- Water damage due to faults or failures of the plumbing system or drainage system.
- Improper substrate leveling and preparation, as well as any defects or failures of patch compounds, fillers, adhesives, or other subfloor leveling compounds which can affect the performance of the Silencer QuickLay spray adhesive
- Subfloors not level to within the flooring manufacturer's installation instructions and tolerances.

### **Warranty Action:**

Foam Products warrants that it will (one time only) at its sole discretion, repair, replace, or reimburse on a (sq.ft.) basis its product should it fail to maintain its bond after its installation. Foam Products will reimburse reasonable replacement labor resulting solely from a defect in Silencer QuickLay spray adhesive. If Silencer QuickLay spray adhesive is no longer available, it will be replaced with a similar quality product. This exclusive warranty will be effective only if the Silencer QuickLay spray adhesive is installed and maintained in full compliance with the manufacturer and the vinyl and carpet tile flooring manufacturer's instructions, recommendations and specifications. Foam Products reserves the right to have an onsite inspection report performed by an independent flooring inspection company for the purpose of determining the actual cause of any damage in advance of any replacement work. Submittal of the flooring manufacturer's product warranty and a copy of the original materials and labor (invoices)

are required. All claims repaired and/or replaced without prior written authorization will void the warranty. Foam Products is not responsible for replacement costs associated with subfloor preparation, moldings/doors and other sundries and their installation, travel, meals or lodging expenses, furniture moving, loss of use, or any other incidental and/or consequential damages due to product replacement.

\*This warranty applies to the original purchaser and is non transferable. A claim must be sent to Foam Products with the original receipt of purchase. This exclusive warranty gives the purchaser specific legal rights and the purchaser may also have other rights, which can vary from State to State.

UNDER NO CIRCUMSTANCES WILL FOAM PRODUCTS BE LIABLE FOR ANY DIRECT, INCIDENTAL OR CONSEQUENTIAL DAMAGES.
